Dear Mr. Coote:


I never thought I would have to write a letter such as this! It has come to my attention that the true nature of the activities being conducted on Amateur Radio by the Sixty-One Support Group repeater located at the KJOI site are less than desirable. I have enclosed a copy of a letter sent anonymously, to the KJOI Corporate Management regarding the Sixty-One Support Group Repeater. At first I thought this was a crank letter being sent by some rival amateur repeater group because of the reference in there to my having received some correspondence from this group, which is a falsehood. However, after listening to the cassette tape that was enclosed and talking to some amateur radio operators regarding the operation of your repeater, it becomes obvious that everything alluded to in the letter is accurate.

Per the Lease Agreement, dated April 5, 1984, Article 10., Page 10, EARLY TERMINATION, either party has the right to cancel the Lease at any time, without cause, by giving the other party thirty days written notice. Please consider this letter your notice to vacate the KJOI premises by no later than October 21, 1984. However, if you can prove to me that the activities being carried on by your repeater have changed radically and that these undesirable broadcasts will not reoccur in the future, then I will consider rescinding the cancellation. I do not wish to act as a censor in any way to your activities; but, on the other hand, we cannot condone the type of operation you have been running and have your operation associated in any way with the KJOI image in the community. There are other locations along the Santa Monica mountains to which you can move your repeater so leaving the KJOI site should be of no real hardship to you.

If you wish to remain at our site I will need some assurances from you in writing of what steps you have taken to eliminate the type of transmissions which are commonplace on your repeater and what steps you will take to insure that this does not happen in the future. Please be assured that I will be monitoring your transmissions from time to time to insure compliance with these requests.

Gentlemen:

Enclosed, please find one audio tape containing some of the most vile, demented, obscene, profane and indecent language you can possibly imagine.

Pardon me for beginning in such a shocking manner, however, it is IMPERATIVE I do impress upon you the severity of a repulsive situation involving your company.

There exists on the KJOI tower in Los Angeles, a two-meter amateur transmitting antenna which is connected to system equipment owned and operated by one Jay Coote. I do believe arrangements for its placement were made prior to Nobles acquiring ownership of KJOI. Thus, I am reasonably certain you are unaware of the nature of the language used on Mr. Cootes repeater. I feel compelled to help increase your awareness. In fact, it is imperative!!!

Several months ago I directed a correspondence to John Davis, Tower Consultant at KJOI, informing him of the following: The language which may be heard DAILY on Mr. Cootes repeater is among the worst imaginable. The subject matter (MASTURBATION, ORAL-SEX, ANAL-SEX, PEDOPHILIA, HOMOSEXUALITY AND OTHERS ) is treated in such a manner that the only reason for becoming involved in a conversation is to see who can best "gross-out" the other participants. Subjects are not discussed from a "clinical" standpoint, but rather in the manner that makes the "crudest comment" the "better comment."

Certain individuals on the repeater, in particular one Philip Tripoli, have been and may still be, the subject of a Federal Bureau of Investigation investigation for threats upon Federal Judge Manuel Real. This may be VERIFIED by contacting F.B.I. Special Agent Wayne Cassetty at (213) 996-2200 or Joseph Merdeler Attorney At Law at (818) 994-8843. Joseph Merdeler is well versed on the matter and is a most helpful individual, He has had many contacts with other individuals who feel as I do that there is no need for vulgarity in amateur radio or society in general. The seven "no-no's" are mild when compared to the language and descriptive terms used on Mr. Cootes repeater.

Why the management of KJOI chooses to involve its-self, even only as a landlord or rentor of antenna space, is not the purpose of this letter. However, the dissemination of "garbage" does originate at an antenna located on your property, thus, even though it is indirect, in the eyes of the public--YOU ARE INVOLVED. For this reason I feel bound to supply you with sufficient information, so that you may evaluate the worth of you continuing a relationship with Mr. Coote. I believe you are deserving of this much, prior to my making the aforementioned fact public.

In order to supply you with as many examples of the horrible type of operation on Mr. Cootes repeater, it was necessary to "edit" the enclosed audio tape. The editing WAS NOT done in an effort to make the subject matter and language appear worse than it actually was, but, rather to be able to increase the number of examples for your evaluation.

Mr. Merdeler can verify that physical violence is not beyond those who operate this repeater. This reason makes it impossible for me to identify myself at this time. I fear that if this letter and my identity were made known to the users of Mr. Cootes repeater, my life and the life of my family would be in jeopardy. Far fetched I admit, but so very TRUE. I do hope you can understand this and do not think me just some kind of "nut" who has a crusade. I am not a prankster, nor am I just complaining over a few bad words. This is VERY SEVERE and I ask your help in stopping further transmissions .

The supporters gave because they were THANKFUL they had a place where they could go to talk baout things which are frowned upon elsewhere. UNFORTUNATELY, WARD FELT OTHERWISE. He did not like those who could talk about things on the air. He himself cannot discuss anything in any manner.....logic is NOT one of his better qualities. Anyway, he began to hit on Coote to "stop this type of operation". Coote, was easily persuaded, anf quickly fell prey to the "WARD TYPE MENTALITY". The hate quickly spread and the downfall was in progress. The end would come soon.....or so they thought. A well palced letter to NOBLE BROADCASTING brought the temporary end of COOTE, WARD AND COOK as far as a 01/61 type of repeater is concerned. Now, Coote was really mad. Can he convince the "new" site owner that he won't be subjected to hundreds of calls....letters.....public pressure....just as the NOBLE owners were (and the current site owner is soon to be subjected to). READ ON LADS AND FIND OUT WHAT THE PLAN OF THE GAME IS GOING TO BE! You, as well as I, will enjoy each and every minute in the continuing saga of; "AS THE SITE IS LOST BY COOTE, WARD AND COOK".

CONTINUED.....They say it is not good to disclose your game plan to the enemy. Yet, this game plan CANNOT FAIL. There is NOTHING to be lost by telling EXACTLY what we plan to do. It will only serve to make the final demise a bit bit better in the near future. You will see that the plan cannot and will not fail. You will applaud our efforts and praise us as masters of intimidation. The memory of Ed Hunter and James Houghton will be forever imprinted on your minds. Free and Open will once again be the ruler of the air. LICENSED HAMS, and Hunter and Houghton are LICENSED HAMS, will prevail. HATE, FEAR AND VERBAL ABUSE OF OUR RIGHTS TO FREE SPEECH WILL NEVER AGAIN BE THREATENED! WE are to be victorious! WE ARE CHAMPIONS.....WE ARE VICTORS....WE ARE LICENSED, LEGAL HAMS!!!!

Soon, probably within the next three weeks, letters will be sent to the current site owner, city officials, county officials, private corporations, political officials and the news media. Contained in these documents will be factual proof of the horrible type of operation which COOTE, WARD, COOK and OTHERS support. Tapes will be sent (there are as of this letter six 90 minute tapes) containing outtakes and UNCUT conversations which we have recorded over the past fifteen months. As with Noble, the individuals who receive these tapes will not want to censor anyone....however, political pressure will dictate that they MUST. Financial ruin will result if in the end they decide they should not. I am certain you and I cannot function without financial compensation; just as they cannot function without same. What politician wants to have it known that supports granting contracts to someone who is morally questionable and supports a type of operation as he hears on the tapes we have so kindly furnished. The news media would love to get their hands on this type of "DIRT".

In addition to the above documents and tapes, records obtained from the District Attorney which clearly show the questionable character of these individuals will be sent for evaluation by the various agencies. Tape recordings made with the knowledge (and without) of these individuals will be sent along for evaluation. Photographs of one of the individuals will be included.....LETTERS which were sent to underage female users will be photocopied and sent to help support the "questionable" moral character of the current repeater operator. should mention, these letters are in his own handwriting and cannot be contested. Statements of various underage females will be included for more of a "shock value" than anything else. Dates, times and hotel receipts will included, along with sworn statements from the participants (underaged females again) and their parents.

As you can see, our plan cannot fail. Even if only ten per-cent of the plan is the unbiased truth. There is not a businessman in the state who wants to put up with losing business thanks to a few bucks he receives as payment for site rental. The times are too tough to expect anyone to take the beans from his table solely to help further a ham's silly desire to own a repeater.

The good news for all is that immediately following the removal of the COOTE, WARD and COOK repeater, there will be placed on the air a BRAND NEW, SOLID STATE, FULL OPERATION AL REPEATER in the HILL OF HOLLYWOOD. Site location will be public knowledge and totally free of any outside influences. There will be no rental, as the site is in a PRIVATE HOME!!!!!! The site owner is a ham and her property is secured from all sides. Entry is by electronic identification and there is a 24 hour per day security guard on premises. You have all talked to this ham and will remember her the first moment HER MACHINE ID's!

Truly, the end is near for COOTE, WARD AND COOK. They WILL BE WELCOME ON THE NEW MACHINE, but, ONLY AS LONG AS THEY HAVE RESPECT FOR THE NEW OPERATING RULES.....NO HATE, NO VIOLENCE AND NO CONTROL BY ANYONE OTHER THAN THE HAM WHO IS TALKING AT ANY GIVEN MOMENT! If they violate these rules, they will be asked to take their opinion elsewhere. They are welcome as long as they can stand FREE SPEECH, NO HOLD BARE, SAY WHAT YOU FEEL, AND MOST IMPORTANT.....NEVER ASK ANYONE IF THEY ARE LEGAL! THE JOB BELONGS TO THE FCC NOT HAMS!! The touch-toners, funny voices, troublemaker types will be a small part, but real part, of operation on the NEW machine! They won't win if you don't give them too much publicity. If you allow them to consume you, then you will turn out as COOTE, WARD AND COOK! NUTSOS!

I will close now with a few words from my dear old mother: GO AHEAD MOM!!!!!!!!!!!!!!  
OK MOTHERFUCKERS.....THE GAME PLAN IS THIS.....HIT THOSE GOODIE TWO SHOE BASTARDS IN A PLACE WHERE IT HURTS! LET'S HEAR IT FOR GOOD TIMES AND LAUGHTER! PISS ON CONTROL OPS!!!

SEE YA LATER SONNY BOY!!!!!!!!!!!!



JAY: THE FIGHTING HAS GOT TO STOP NOW OR THE REPEATER IS DONE FOR ONCE AND FOR ALL, THE PURPOSE OF "TAKE A NUMBER" IS TO TRY AND IMPRESS UPON YOU THE SERIOUS NATURE OF THE EVENTS OF THE LAST TWO WEEKS. THE MAIN TOPIC SHOULD BE, "GET THE REPEATER TOGETHER AGAIN", BUT, AND YOU CAN BELIEVE IT IS TRUE, IF THE FIGHTING FOR REAL DOES NOT STOP, THERE ARE FACTIONS PRESENT WITHIN THE GROUP THAT WILL WORK WITH ALL THEIR HEART AND SOUL TO SEE THIS THING FALL AND YOU WITH IT IF NECESSARY.

I AGREE, NO BOOTLEGGERS ETC., BUT BEYOND A SIMPLE ID EVERY 10 MINUTES, ANYTHING GOES HAS GOT TO BE THE POLICY. NATURALLY, NO JAMMING , THAT GOES WITHOUT SAYING.

THE THING CAN WORK AGAIN, BUT NOT WITH THE THREAT OF VIOLENCE HANGING OVER THE HEAD OF ITS USERS. NO MACHINE CAN SURVIVE THAT WAY.
